#### ORDER:

In his letter seventh read above, the Managing Trustee, Smt.G.Gandhimathi Educational Trust, Tiruvannamalai has requested the Government for granting permission to start four years B.Sc. (Nursing) course in the name of Gandhimathi College of Nursing at Nallan Pillai Petral Village, Tiruvannamalai Taluk and district.

- 2. In the Government letter eighth read above, the Director of Medical Education and Research was requested to conduct an inspection on the premises of the said institution and report. Accordingly, the Director of Medical Education and Research has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.
- 3. In his letter ninth and eleventh read above, the Director of Medical Education and Research has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Managing Trustee, Smt.G.Gandhimathi Educational Trust, Tiruvannamalai to start four years B.Sc. (Nursing) course in the name and style of Gandhimathi College of Nursing at S.F.Nos.68/2C1A1 and 68/2C1A2, Vettavalam Road, Nallan Pillai Petral, Tiruvannamalai 606 611, with an annual intake of 60 (sixty) seats.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and Research and decided to accept the same. Accordingly, the Government hereby grant No Objection Certificate to the Managing Trustee, Smt.G.Gahdhimathi Educational Trust, Tiruvannamalai to start four years B.Sc.(Nursing) course at Gandhimathi College of Nursing in S.F. Nos. 68/2C1A2, 68/2D2 & 69/3, Vettavalam Road, Nallan Pillai Petral Village, Tiruvannamalai 606 611, with an annual intake of 60 (sixty) seats from the academic year 2024-2025, subject to fulfillment of the following specific condition along with other general conditions laid down in Government Orders fifth and sixth read above as applicable to this proposal before admitting the students:
  - i. The trust should submit the change of name and registration address in the vehicle Registration Certificate of TN-25-AF-8399 and TN-25-AP-0289 to Gandhimathi College of Nursing within three months of issue of permission orders and Director of Medical Education and Research to ensure the same.
  - ii. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and The Tamil Nadu Dr. M.G.R. Medical University, Chennai and if needed, suitability from Indian Nursing Council, New Delhi.
- The Director of Medical Education and Research is directed to take necessary further action accordingly.
